Stronger COVID-19 Measures in Kyoto

16th April, 2021 Kyoto Prefectural Government

Requests to universities

(Requests based on Article 24 Clause 9)

- Actively utilize online classes at universities, etc. to reduce the number of students coming to class at one time to 50% or less.
- Be sure to comply with university guidelines. In particular, take infection prevention measures such as
 introducing a permit system for students' club activities, canceling or postponing trip plans to other prefectures
 for competitions/ games. If such a trip cannot be cancelled or postponed, conduct PCR testing in advance and
 confirm that the results are "negative" before going ahead.
- Cooperate with the COVID-19 monitoring tests, etc. at universities in the prefecture, which are being carried
 out by Kyoto Prefecture in cooperation with the national government.
- Refrain from dining with people before and after university classes and extracurricular activities.
 (Comply with "Kyoto Manners")
- Thoroughly implement infection prevention measures at student dormitories.
- Alert students not to conduct the following:
 - No visiting restaurants or bars outside of their requested business hours
 - No partying with university club members
 - No gathering with a large group or no staying overnight at a friend's apartment
 - No talking without a mask even during a meal.

Requests to junior and senior high schools

- Based on the actual situation of each school regarding commuting to school, take infection prevention
 measures such as staggering commuting hours to school to avoid congestion time of public
 transportation, or shortening each time for class to avoid a crowded situation right after school.
- Infection prevention measures regarding club activities in junior and senior high schools, including these
 activities being conducted only by students of each school, inside school premises, within 2 hours, and
 an accommodation ban, should be thoroughly implemented.
- Regarding participation in official competitions and presentations where sufficient infection prevention
 measures are taken, confirm with an organizer in advance that the infection prevention measures are
 being taken.

Stronger measures against the COVID-19 in Kyoto

- I. Area that the measures must be carried out: Kyoto Prefecture
- II. Duration: From 12th April to 5th May, 2021

- Refrain from outings (All over Kyoto Prefecture)

1 Refrain from outings (All over Kyoto Prefecture)

(Request based on Article 31-6 Clause 2 and Article 24 Clause 9 of the Special Measures Law)

 Please don't visit restaurants outside of the requested business hours for these establishments.

(Request based on Article 24 Clause 9 of the Special Measures Law)

- Refrain from non-essential and non-urgent outings during the day and avoid crowded places and times.
- Refrain from non-essential and non-urgent travelling into areas out of Kyoto Prefecture.
- Refrain from visiting areas where the infection risk is high (places such as restaurants, bars, and Karaoke venues that fail to carry out thorough infection prevention measures based on the guidelines by industry)

2 Restrictions on events (All over Kyoto Prefecture)

Request to comply with the following criteria for event organizers and facility management

(Article 24 Clause 9 of the Special Measures Law)

【Upper limit of the number of people】 5,000 people or less

[Capacity rates]

Cases with no loud cheering: 100% or less

Cases with loud cheering: 50% or less *

* Allow for vacant seats between groups, if a group of people is less than 5, then there is no need to leave spaces (in that case it may exceed the capacity rate of 50%)

Upper limit for the number of people in attendance should either be 5,000 or less, or below the above stated capacity rates, whichever is smaller.

Prior consultation

If an event involves nationwide movements of people, or more than 1,000 participants, an event organizer must consult with the Kyoto Prefectural Consultation Office in advance.

3 Restrictions on facility usage (Within Kyoto City)

* For the duration of the period, Kyoto Prefecture and Kyoto City will cooperate to provide individual confirmation guidance to restaurants, etc.

(2) Facilities to which the Special Measures Law does not apply

For facilities such as theatres, assembly halls, sports facilities, and amusement parks, with regards to Article 11 of the Special Measures Law Enforcement Ordinance, we will work to shorten business hours to 20:00 (with the serving alcoholic beverages taking place from 11:00 to 19:00) regardless of the Special Measures Law.

4 Restrictions on facility usage (Outside of Kyoto City)

(1) Requests based upon the Special Measures Law

Only 15 municipalities in the Yamashiro and Otokuni areas are requested to shorten business hours.

5 Commuting to work (All over Kyoto Prefecture)

We request business operators to thoroughly implement teleworking (Article 24, Clause 9 of the Special Measures Law)

 With the goal of "reducing the number of employees in the workplace by 70%", teleworking should be promoted, alongside initiatives such as work rotations, and staggered working hours for places where attendance is required.
